- 5) This certificate does not imply any warranty against damage or personal injury incurred due to modifications made to the platforms unless approved in writing by an authorised Royal Wolf Trading engineer
- 6) This certificate does not imply any warranty against damage or personal injury incurred due to improper installation, ground support, and/or hold down anchorages to ensure stability on the particular site
- 7) Design and certification of footings or counter weighting required for stability on any particular job site is explicitly excluded from supply
- 8) This certificate is limited to the loads and design actions applied to the 20' Platform, as directly stated in Table 1.2. All other loading conditions, whether it be due to the attachment of other equipment, on-site installation, or otherwise shall void this certification
- 9) Concentrated actions shall be limited to the values prescribed in Table 1.2, and depicted on drawing RWT-CSC-PL007-001, Revision A (refer Appendix A)
